## FROM THE NATIONAL LEGISLATIVE DIRECTOR —

n February 14, 2019, the House & Senate approved the final seven FY2019 spending bills after nearly five months of short-term extensions and the longest government shutdown in U.S. history. This legislation wrapped up all 12 Appropriations packages and will also prevent anymore shutdowns from occurring through the end of the current fiscal year ending October 1, 2019. As we reported in earlier information, the final funding for rail operations was \$218 million less than the record-setting levels in FY2018, largely due to a drop in funding targeted at the Northeast Corridor. The bill still provides \$1.9 billion for Amtrak, equal to last year, and \$670 million for rail infrastructure improvements. It also includes several key provisions that NARVRE members and all rail passenger advocates fought for ... as follows:

- A statement from Congress that long-distance passenger rail is an essential part of the nation's transportation system, specifically for rural parts of the country, and should be retained to ensure connectivity throughout the National Network;
  - Requirements to invest in capital

improvements for the Southwest Chief, and a prohibition on the use of these funds to "discontinue, reduce the frequency of, suspend, or substantially alter" the route;

- Bringing back station agents to any Amtrak station that had a ticket agent position eliminated in FY 2018;
- Congressional direction to Amtrak to improve communication and collaboration with area communities to enhance local jobs, when making decisions related to the staffing of Amtrak stations.

The news for transit was largely positive, with the Federal Transit Agency receiving \$13.4 billion. That's a reduction of \$67 million below the FY2018 enacted level--but

\$2.3 billion above the Trump budget request.

We continue to hear from members with favorable reports on the success of getting their death benefit policies updated as well as collecting benefits from Met Life. Recently, we have been advised that our retiree members can be using an additional number to access Met Life. The latest tip is to use 800-638-6420, and click on Option # 2, which will connect you to the Met Life Claims Dept. We also have been advised that Long Island retirees have a different phone # to call as they have their own Death Benefit contract with the MTA LIRR. The correct # for those retirees is 646-376-0123...Again, this # is only for MTA LIRR employees and retirees. As a reminder, we are still relying on the ground work of NARVRE member Paul Iversen, Unit # 92, Duluth, MN. (218-834-5248), for questions and advice on the \$2000 Death Benefit with Met Life Insurance Co. Paul and fellow members have been circulating their information to retirees in and around areas in MN, and since 2016, they've recovered over \$550,000 in death benefits from Met Life. However, the work load has grown enough that Paul and NARVRE put together a packet filled with pertinent information helpful for all affected rail employees. We have urged every Unit to have a designated member to be the point person on this Met Life issue. Packets are still available from Phil Steward @ the Nat'l Sec-Treasurer's office. NARVRE emails and phone numbers are located on the front page of this Newsletter. The packet is key for advice and answers, and especially helpful in our recruiting efforts. Your fellow members and rail retirees will thank you for your involvement.

# **April is Alcohol Awareness Month**

April is also Alcohol Awareness Month, and for this month's newsletter, I'd like to discuss the Medicare preventive services: annual alcohol misuse screening and counseling.

The United States Preventive Services Task Force (USPSTF) defines alcohol misuse as risky, hazardous, or harmful drinking which places an individual at risk for future problems with alcohol consumption. Their research found that women who consume more than seven drinks per week or more than three drinks per occasion, and men who have more than 14 drinks per week or more than 4 drinks per session, were more likely to have elevated risks for many health problems.

Alcohol dependence is defined as at least three of the following: tolerance, withdrawal symptoms, impaired control, preoccupation with acquisition and/or use, persistent desire or unsuccessful efforts to quit, sustains social, occupational, or recreational disability, use continues despite adverse consequences.

Alcohol misuse screening and counseling are preventive services you can have each year if you use alcohol but do not meet the criteria for alcohol dependency. This benefit allows for one alcohol misuse screening and, if you screen positive for misuse, up to four brief face-to-face counseling sessions. Medicare will cover the annual screening and counseling when provided by a primary care physician or other primary care practitioner in a primary care setting. You must be competent and alert during the counseling.

These preventive services are

available at no cost to you, if the primary care doctor or other primary care practitioner accepts Medicare assignment.
