FROM THE NATIONAL PRESIDENT —

Pour years ago we started monitoring several factors when it comes to membership as it relates to Unit closures in 2015 we had 144 Units while today we are down to approximately 115 Units in 2019. Many of those closures were Units where there was no potential growth as the railroads closed terminals leaving behind just a hand full of people and mostly retirees.

Fast forward to 2019 we see healthy Units with members in arrears not collecting dues for this cycle. This is not a handful of Units but a pattern nationally. If this continues to take place and Units close it will affect the overall structure of NARVRE in the future. We need Units to conduct business such as our convention every two years. At Large members (801) do not constitute a Unit for convention purposes.

We can tell by our records in 2019 that just about every Unit is in arrears with delinquent dues. May I suggest to you to set up a calling committee to reach these members as many of them may have moved, gone to assisted living or moved in with their children. Some may even have passed away and we were not notified.

The excuse of the 2018 convention dues increase is not a valid argument. The increase in dues had to be done or we would have to close up shop in a few years. It should have been done many years back but was neglected. The bottom line is we had to be fiduciary responsible. We all need to do our part and contact the members who have not paid for 2019. It is your organization that needs to be preserved.

FROM THE NATIONAL LEGISLATIVE DIRECTOR —

In keeping with our continued support for two-person train crews, NARVRE recently emailed our members urging them to contact their Member of Congress, requesting that they co-sponsor H.R. 1748, The Safe Freight Act of 2019. This legislation was again introduced by Rep. Don Young (R-AK), who authored and proposed similar bills in the 114th Congress (HR 3040) and the 115th Congress (HR 233). H.R. 1748 will mandate that two certified crew members are required to operate freight trains on U.S. rails, which will help ensure the safety of neighboring communities and freight rail employees. If you haven't made contact with Congress, as yet, please take the time to do so now.

In previous articles and emails, we have reported on the adverse proposals and actions of Amtrak's CEO, Richard Anderson, who has directly furloughed and/or affected hundreds of experienced employees by his closings of stations and call centers. NARVRE's membership and overall association have continually supported this national rail passenger train service and the employees that work for Amtrak. We always enjoy any apparent success as an outcome of our work with Congress, and it is always appreciated when members of the House or Senate directly respond in an active manner, and schedule committee hearings in order to ask the hard questions of those in charge. That happened recently in a Senate transportation committee hearing when an Amtrak Vice-President testified on behalf of Mr. Anderson but left the feeling and suspicion that he deliberately avoided key questions without a direct response. One of those questions dealt with the concern that Amtrak's accounting is intentionally obscure and causing false inflation on costs of lines outside of the Northeast Corridor (NEC), even though long-distance and state-supported trains generate more ridership than the NEC, with similar levels of revenue. Accordingly, after the hearing, on April 5th, a bipartisan group of Senators wrote directly to Mr. Anderson, expressing their strong support of Amtrak's entire national network, to include routes that serve small to large size communities and provide critical connections to families and their jobs and travel. They made it clear that Amtrak is subsidized by a bipartisan Congress which acknowledges the entire network to include long-distance and state-supported routes, and is committed to "preserve and expand those routes".

The letter was signed by Senators Tester (D-MT), Udall (D-NM), Bennet (D-CO), Roberts (R-KS), Gardner (D-CO), Moran (R-KS), Cortez Masto (D-NV), Heinrich (D-NV), Manchin (D-WV), Durbin (D-IL), and Sinema (D-AZ).

The letter included many specific questions from the Senators:

From the National Vice President —

e are now in the middle of the year expecting to have reached all or most members that are delinquent to paying membership dues, but the fact is we are still behind but definitely closer to being in a safe financial condition. I cannot ask or stress enough the importance of bringing up asking all officers of all units to implement recruiting committees to reach out making personal calls to those that are delinquent in their dues. It is important to reach out to only those that have not paid to find out if they are doing okay. Many may have health conditions as it happens every year with our membership. We have made progress throughout the years to maintain a safe number of members and this time we are not stopping. The original small number of retirees and activist did not relent to making this organization grow. So, please continue to make NARVRE strong by reaching our primary goal of NARVRE that is to Promote, Protect, Preserve our Railroad Retirement Pension annuity. As well as to protect our Railroad Retirement Pension Annuity, Medicare and Medicaid, Social Security our Tier 1 of our Railroad Retirement, an affordable Health Care and all senior benefits we worked for and paid for by our both our employee and employers during our working-lifetime. We earned those benefits and we expect to collect as we gave up certain concessions in exchange for working conditions and benefits. I continue to encourage all Area Directors to communicate with your respective NARVRE Unit officers to inquire the status of their member-

his month we sent out new rosters to all units and the response has been tremendous. The average rate of members membership delinquency rate nationally is 29% and from a monetary standpoint calculates to nearly \$88,000 of uncollected revenue! This amount is alarming and would resolve our organization's financial issues. These funds could be used to pay for outreach programs to build membership, allow more officers to travel for unit visitations, purchase recruitment materials, address convention expenses, and pay for advertising.

We are mailing over 1100 notices to 801 members and a few units desiring assistance this month. In past mailings, we received 30% to 50% response from these notices.

Unit officers, as indicated in last month's article, members marked A/L - late status on your rosters are unfortunately not receiving their newsletter and resumption will not occur until dues are made current. As a matter of policy, the National Office will not remove a member from active status until we receive information from the Unit Officers or directly from members wishing to be withdrawn. Before removing a member from the roster, every effort should be made to contact the member via telephone or written communication.

Unit 071 Temple TX President Jay Weaks initiated a new unit Face-book page and we encourage other units to do the same. If you have started a new Facebook page or need assistance please let us know by contacting the National Office.

Finally, we certainly appreciate the generous donations this year large and small. A check for \$50.00 was donated by National Vice President Tony Padilla who is challenging all organization officers to do the same. - On Amtrak's decision to eliminate ticket agents, why did Amtrak calculate totals based on weekly boardings on routes that do not run daily?
- Amtrak's accounting methods used to determine the cost of operating a long-distance service.
- Is Amtrak planning to alter any long-distance train routes?
- Which routes are under consideration for alteration?
- Would any of these routes be altered in such a way that they would fall under the definition of state-supported routes, requiring states to find local operating funds for existing service? What discussions has Amtrak had with states, if any, that lead it to believe that states would be willing to assume this financial obligation?
- What basis does Amtrak claim that demand for long-distance service is down, despite ridership numbers growing?

The Senators closed their letter with an expectation that Amtrak should respond to their questions by April 29, and to a Congress and the law which governs the entirety of Amtrak.

Medicare Fraud Strike Force Conviction Worth \$1.3+ Billion

federal jury convicted South Florida Medicare provider Philip Esformes (Miami Beach) of the largest fraud scheme ever charged by the Justice Department. The total amount of the fraudulent claims filed to Medicare and Medicaid was more than \$1.3 billion. The claims were either not medically necessary, not performed, or performed via payments of kickbacks.

Per the Department of Justice: "Philip Esformes orchestrated one of the largest health care fraud schemes in U.S. history, defrauding Medicare and Medicaid to the tune of over a billion dollars," said Assistant Attorney General Benczkowski. "I commend our dedicated prosecutors and law enforcement partners for their professionalism and unyielding pursuit of justice on behalf of American taxpayers and vulnerable beneficiaries who, as a result of Esformes's crimes, were denied the level of care that they needed and deserved."

This case was solved via a joint investigation by the FBI and Health and Human Services – Office of Inspector General (HHS-OIG) and was brought as part of the Medicare

Fraud Strike Force activities. Medicare Fraud Strike Force teams run investigations in the following areas:

Miami, Florida; Los Angeles, California; Detroit, Michigan; Houston, Texas; Brooklyn, New York; Baton Rouge and New Orleans, Louisiana; Tampa and Orlando, Florida; Chicago, Illinois; Dallas, Texas; Washington, D.C.; Newark, New Jersey/Philadelphia, Pennsylvania; and the Appalachian Region.

Since its beginnings in 2007, the Strike Force has charged almost 4,000 defendants who have filed claims to Medicare and Medicaid worth more than \$14 billion. They investigate claims for both Medicare Part A (hospitals, facilities) and Part B (doctors, non-physician practitioners and some suppliers).

What You Can Do to Help Fight Fraud, Abuse and Substandard Care

While the Strike Force teams target all of Medicare (including providers who also submit claims to Railroad Medicare), you are the first line of defense when it comes to identifying Medicare fraud, abusive billing and substandard care. Here's how you do it:

- Thoroughly read your Medicare Summary Notices (MSNs) either in print or online, however you have chosen to receive them. If you spot services that you know were not rendered, please contact our Beneficiary Contact Center (BCC).
- If you or a loved one receives substandard care from a professional or a health care facility (for example, misdiagnosis, medication errors, unnecessary diagnostic testing or surgery, inadequate discharge instructions, poor facility conditions), you may contact the Beneficiary and Family Centered Care (BFCC)-Quality Improvement Organizations (QIOs). They manage all quality of care beneficiary complaints nationally. You may locate a QIO at https://qioprogram.org/contact.

To contact the BCC, please call 1-800-833-4455, Monday through Friday, from 8:30 a.m. until 7 p.m. ET. For the hearing impaired, call TTY/TDD at 877-566-3572. We encourage you to visit our website at www.PalmettoGBA.com/RR/Me and our Facebook page at www.Facebook.com/MyRRMedicare.
