FROM THE NATIONAL LEGISLATIVE DIRECTOR —

n Saturday, March 14, the U.S House of Representatives passed H.R. 6201, The Families First Coronavirus Response Act, the second emergency funding bill to respond to the COVID-19 pandemic. This legislation, supported by Republicans and Democrats, helps address the increasingly severe economic and health impacts on Americans' personal safety and financial security. The Senate passed this bill by an overwhelming bipartisan vote and the President signed it into law on March 18. The bill provides paid emergency leave, with two weeks of paid sick leave and up to three months of paid family and medical leave. It will provide unemployment benefits to laid off and furloughed workers. This legislation strengthens nutrition food initiatives, including the Supplemental Nutrition Assistance Program (SNAP), student meals, meals for seniors and food banks. It also increases funds for Medicaid to support local and state health systems. The legislation eliminates patient cost-sharing for COVID-19 testing and related services, to include Medicare Part B, Medicaid, and most forms of coverage. Cost-sharing is defined as deductibles, co-payments and coinsurance (some states have adopted similar requirements for insurers they regulate, and many private insurance companies will voluntarily expand coverage for testing). The prohibition on cost-sharing in all instances would apply for the duration of the emergency period.

From the National Vice President —

The National NARVRE Biennial Convention of May 2020 has been postponed. I want to congratulate and thank the Host Committee for the preparation of the convention and at the same time working to protect the delegates in the work for the postponement, going forward.

My message to the membership was to Promote, Protect and Preserve our RRB Pension Annuity due to the formation and creation of the Railroad Retirement and Survivors' Improvement Act of 2001, signed into law December 21, 2001. The legislation liberalized early retirement benefits to retire at 60 years of age with 30-year service for employees and their spouses, eliminated a cap on monthly retirement and disability benefits, lowered the minimum service requirement from 10 years to 5 years of service if performed after 1995, and provided increased benefits for some widow (er)s' annuities. Most important Rail Labor and Rail management created the National Railroad Retirement Investment Trust (NRRIT) a fund better known as the 'TRUST' allowing Rail Management and Rail Labor to oversee and manage the investments of the funds. Currently the Trust Fund has a balance of \$27.9 Billion in investments and assets that would fund the RRB Retirement benefits for the next 45 and up to 75 years in the future. This is provided that there are no Government infringements to our Fund by executive order or otherwise by the Congress.

Congress had earlier passed the first emergency bill for \$8.3 billion to be immediately available to fight the coronavirus disease. That bill designates \$3.1 billion for direct research and development of vaccines, tests, and other treatments, and for medical supplies to cover surge capacity. Another \$2.2 b goes to federal, state and local health agencies. There will be a 3rd piece of legislation (CARES ACT, HR 748) coming in the days ahead, as the Senate works to pass this stimulus bill. This will be well over a \$1 trillion aid package intended to help weather the COVID-19 economic disaster. Economic reports claim it will likely deliver an average \$3000 payment for a family of four within a three-week period following the POTUS signing it into law. The rough framework further contemplates a second round of checks in a similar amount would be issued six weeks later. Republican and Democrats are still in negotiations for this economic package, as of today, March 23. The two parties have major differences over an anticipated amount of \$58 billion going to the airline industry. Democrats are demanding that any form of a bailout must begin with "workers first", and therefore, they want employees protected by prohibiting corporations from buying back stock, in order to reward executives and/or laying off workers. The airlines are being asked to take stimulus funds in guaranteed loans, and members of both parties are asking for certain restrictions because they are fearful any bailout funding might be used for executive compensations. Earlier in the week, the former U.N. Ambassador Nikki Haley (R-SC) quit her position on Boeing's Executive Board over the company's request for a government bailout. The latest draft reports indicate that Amtrak will receive \$1 billion for the Amtrak Nat'l Network, and rail transit will get \$20 billion for urbanized transit systems and rural area formula grants. Due to the effects of this crisis, Amtrak and rail transit have every right to receive stimulus funding as new data shows that daily ridership is down more than 60 percent, with future bookings down 80 percent year-over-year and cancellations are up more than 400 percent. However, the Trump White House has a history of ignoring the needs of the Amtrak network, and has put forth budget proposals that would mean the demise of Amtrak and the loss of thousands of American rail jobs, all paying into railroad retirement. NARVRE earlier requested that our members contact both the House & Senate to insist that Amtrak be a part of any stimulus funding packages during this coronavirus crisis. We are working again with Railroad Passenger Association, rail labor, and other rail passenger supporters in our efforts to get Amtrak and rail transit included in this current legislative package in the Senate. Effective today, March 24, the Rail Passenger Assoc. announced that the Senate released details of a \$2 trillion stimulus package, which confirms those train service figures, as well as employee protections for rail workers that might be furloughed. Thanks to all NARVRE members for taking part is this campaign. We worked hard to include passenger trains as part of the financial aid package in response to the coronavirus. If Amtrak and transit agencies didn't receive federal assistance in the face of collapsing ridership and tax revenue, some of these services would disappear and not come back. More later...be careful and take care of your families and fellow retirees!

From the National Secretary-Treasurer —

ast month, we recognized the Units that did an outstanding job in reducing the number of late and delinquent members for 2019.

Many accomplished this by calling or mailing to remind members to renew and pay their dues as well as identifying and removing members who were no longer interested and informing the national office of any deceased or medically limited members.

This is month we are recognizing the "early birds" for 2020 dues collections and have 0% - 15% delinquency rate.

We certainly appreciate your time and interest.

The numbers from March 1, 2020 were 4473 delinquent members resulting in \$84,789 in arrears giving us a 31% delinquency rate nationwide.

As a result of your efforts, there are 4023 delinquent members resulting in a \$77, 083 in arrears giving us a 28% delinquency rate nationwide.

We will be emailing and/or mailing rosters to each of our units to further assist units in lowering the delinquency rate. Unit officers, if you do not receive a roster by April 15, 2020, please do not hesitate to request one.

We have received several inquiries whether benefit checks will be affected by the Covid-19 outbreak. Our sources with the RRB indicate no interruption in payments to annuitants.

We were also briefed by local officials be aware the virus could be spread at gas pumps. Consequently take precautions prior to touching the pumps and the cleansing material does not reenter your vehicle ie. gloves or wipes.

Age seems to be a risk factor for poor outcomes but questions remain about the spread and transmission of COVID-19.

Here are some ideas from the CDC of how to protect you and your family.

• There is currently no vaccine to prevent coronavirus disease 2019 (COVID-19).

• The best way to prevent illness is to avoid being exposed to this virus.

• The virus is thought to spread mainly from person-to-person.

• Between people who are in close contact with one another (within about 6 feet).

• Through respiratory droplets produced when an infected person coughs or sneezes.

• These droplets can land in the mouths or noses of people who are nearby or possibly be inhaled into the lungs.

• Wash your hands often with soap and water for at least 20 seconds especially after you have been in a public place, or after blowing your nose, coughing, or sneezing.

• If soap and water are not readily available, use a hand sanitizer that contains at least 60% alcohol. Cover all surfaces of your hands and rub them together until they feel dry.

• Avoid touching your eyes, nose, and mouth with unwashed hands.

• Avoid close contact with people who are sick

• Put distance between yourself and other people if COVID-19 is spreading in your community.

• This is especially important for people who are at higher risk of getting very sick.

• Stay home if you are sick, except to get medical care. Learn what to do if you are sick.

• If you are sick: You should wear a face mask when you are around other people (e.g., sharing a room or vehicle) and before you enter a healthcare provider's office. If you are not able to wear a facemask (for example, because it causes trouble breathing), then you should do your best to cover your coughs and sneezes, and people who are caring for you should wear a face mask if they enter your room.

If you are NOT sick: You do not need to

wear a face mask unless you are caring for someone who is sick (and they are not able to wear a face mask). Face masks may be in short supply and they should be saved for caregivers.

• Clean AND disinfect frequently touched surfaces daily. This includes tables, doorknobs, light switches, countertops, handles, desks, phones, keyboards, toilets, faucets, and sinks.

If surfaces are dirty, clean them: Use detergent or soap and water prior to disinfection. For additional information visit www.cdc. gov/coronavirus/2019
