FROM THE NATIONAL LEGISLATIVE DIRECTOR —

he House of Representatives has narrowly passed a fifth coronavirus aid package (H.R.6800) which responds to the COVID-19 outbreak and its impact on the economy, public health, state and local governments, individuals, and businesses. It will provide loans and grants for small businesses through the Payment Protection Program, as well as a myriad of other programs and policies involving medical issues, student loans, prisons, veterans, postal agency and workforce, federal elections, aviation and railroads, etc. HR 6800 (Heroes Act), will now go to a Republican controlled Senate that will not consider this legislation in its current form.

Senate Majority Leader Mitch McConnell (R-KY) has referred to the House package as dead-on-arrival as the Senate will go on recess through the Memorial Day weekend. McConnell has stated that he does not agree on the financial expenditures in the Heroes Act, citing the overall \$3 trillion tied to this emergency relief bill. However, the earlier CARES Act, was passed by a bipartisan vote, and endorsed by McConnell, and that bill proposes similar amounts of funding at \$2.2 trillion.

These relief packages also identify tax credits and deductions as an item that will be addressed and/or modified, but one would expect a related tax item to be fully transparent and relevant to the emergency of the national coronavirus pandemic. However, the CARES bill included earmarked tax loopholes nestled deep in that 800-page bill without transparent discussions or hearings.

These loopholes promise an average of \$1.6 million for most millionaires. These tax loopholes in the CARES bill should have been discovered and discussed, but wasn't. To be sure, it can and does happen that certain items can be overlooked when huge emergency bills are

Now, when it seems like we are somewhat settling into our new world and limiting the pandemic's reach, the Government is looking to "open for business" and put more frontline workers at risk due to not enough equipment and testing of the population to determine control for a cure. It has been said that this pandemic will linger for eighteen months to two years.

The commitment we make is to continue the great work the officers and units do to keep NARVRE safe and sound. Our Area Directors are encouraged to continue to communicate with all the Unit officers to do membership drives to bring up to date delinquent union dues from those that are not up to date. Units

ran through the Congress in a pressured and rapid fashion. In this case, after the CARES bill was signed into law, the tax breaks became public knowledge.

Analysis reports from the Congressional nonpartisan Joint Committee on Taxation (JCT) and the Tax Policy Center (TPC) indicates that this tax giveaway is estimated to cost over \$135 billion over the next 10 years. According to JCT, it will cost \$86 billion in 2020 alone, the vast majority of over 80% going to taxpayers making more than \$1 million in income as real estate business developers and hedge fund owners.

The tax break comes with no strings attached and there are no requirements that the beneficiaries of the loopholes use the tax savings to retain their employees or contribute in any other way to the response or recovery efforts for the national pandemic.

Congress is responsible to finalize and agree on specific funds to help mitigate the suffering of Americans and relief dollars should be centered around that immediate relief and stimulus. Therefore, NARVRE supports the recommendations of the JCT (with reports from TPC and Americans for Tax Fairness) and joins with the proposals of other senior/retiree organizations that are calling for the repeal of this \$135 billion tax handout for millionaires. Nearly 225 organizations have denounced the tax break handout in a letter to Congress. A report has just been released stating that a legislative repeal will be added

to the Heroes Act and those repeal provisions are being introduced in the appropriate House and Senate Committees.

Amtrak and transit agencies have made new requests for additional funding in the new round of stimulus proposals, which are needed to cover their operating and capital expenses. Latest reports indicate funding levels in the House Heroes Act (HR 6800) are well short of the \$23.8 billion requested by transit and Amtrak was zeroed out, ignoring that request for an additional supplement of \$1.63 billion. All projections were for Amtrak to break even on its operations for 2020, but the impact of the virus pandemic has caused a 95% drop in ridership leading to a probable loss of \$700 million this year. NARVRE will be working for improved Amtrak funding in the final bill, as negotiations should somehow begin after the Memorial Day Holiday. When speaking to our Members of Congress, we need to point to the aforementioned and egregious example when Congress approves the use of federal funds. Our case is to urge them to appropriate reasonable amounts of funding for Amtrak, as well as the Railroad Retirement Board Agency. It is difficult to see how Congress can justify federal handouts to millionaires while ignoring the needs of Amtrak and the nation's rail passenger train service. Let's continue to tell Congress to protect Amtrak and those employees that pay into railroad retirement, which is entirely funded by rail industry and rail employees, and governed by the Railroad Retirement Act.

From the National Secretary-Treasurer —

Through all of the chaos created by Covid-19, one key theme has emerged: the importance of contacting and keeping in touch with our members. We suggest organizing call groups to telephone members, sending post cards, and if you have not developed a unit Facebook page to message present members and outreach to new potential members, now is the best time to do so.

A global survey conducted in March 2020 revealed that the coronavirus has had a direct impact on in-home media consumption around the world, with 35 percent of total respondents professing to have read more books or listened to more audiobooks at home and 18 percent having listened to more radio due to the COVID-19 pandemic, while more than 40 percent of consumers spent longer on messaging services and social media. Interestingly, although at least 50 percent of respondents in most countries said that they were watching more news coverage, figures for Australia and the United States were lower, amounting to just 42 and 43 percent respectively.

Not to be redundant, but at this point in time more Americans being at home, we have a unique opportunity to contact more people by using social media content from our national NARVRE Facebook page. Like our page and send the call to action posts to your friends and ask them to share the word with their friends. Additionally join National NARVRE Forum and post activities or events with respect to your local unit.

Across America our unit officers have been very prudent in postponing or canceling local unit meetings amid the COVID-19 outbreak. As the State and local government officials are lifting Stay-At-Home orders, listed below

deciding to resume meetings. These 11 bullet points were excerpted from www.cdc.gov website. If you desire more information, go to the Center for Disease Control website.

- 1. Check with your state and local health authorities. Public health officials may recommend community actions designed to limit exposure to COVID-19, depending on the risk of an outbreak or
- Promote the daily practice of everyday preventive actions. Use health messages and materials developed by credible public health sources such as CDC or your local public health department to encourage your event staff and participants to practice good personal health habits. Consider displaying signs (physical and/or electronic) throughout the event to provide frequent reminders to participants to engage in everyday preventive actions to help prevent the spread of COVID-19.
- COVID-19 and what to do if organization members/staff become symptomatic.
- Review, update, or develop emergency plans for the organization, especially consideration for individuals at increased risk of severe illness.
- 5. Encourage staff and members to stay home and notify organization administrators of illness when sick.
- 6. Encourage personal protective measures among organization/members and staff (e.g., stay home when sick, handwashing, respiratory etiquette).
- 7. Clean frequently touched surfaces at organization gathering points daily.

Antibody testing should be left to the scientists and medical doctors. - Implement social distancing measures.

Medicare To Cover Limited Acupuncture Service

Por the first time, Medicare will cover limited medically reasonable and necessary acupuncture services for chronic lower back pain. Prior to this change, no forms of acupuncture were covered by the Medicare program. Medicare's new acupuncture limited coverage is as follows:

- Up to 12 acupuncture services/ visits in 90 days for chronic lower back pain
- An additional eight visits may be approved if the treatment results in improvement.
- Up to 20 acupuncture services can be provided yearly.
- Failure to show improvement for your chronic lower back pain, or if the pain worsens, then no additional services will be covered.
- Medicare defines "chronic lower back pain" as a condition that:
 - · Lasts 12 weeks or longer
- Has pain that is not associated with surgery or pregnancy
- Has no identifiable systemic cause such as metastatic, inflammatory or infectious diseases, etc.

According to the Mayo Clinic, acupuncture, also known as "dry needling," involves the "insertion of very thin needles through your skin at strategic points on your body. A key component of traditional Chinese medicine, acupuncture is most commonly used to treat pain." For Medicare, you can receive acupuncture from physician assistants, nurse practitioners/clinical nurse specialists, as well as auxiliary personnel who meet all applicable state requirements and have:

- A masters or doctoral level degree in acupuncture or Oriental Medicine from a school accredited by the Accreditation Commission on Acupuncture and Oriental Medicine (ACAOM); and
- A current, full, active, and unrestricted license to practice acupuncture in a State, Territory, or Commonwealth (i.e. Puerto Rico) of the United States, or District of Columbia, where the service is being performed.

The Mayo Clinic offers guidance on finding an acupuncture professional.

Medicare's coverage of acupuncture is limited to the treatment of chronic lower back pain. Medicare does not cover any type of acupuncture, including "dry needling", for any other condition including fibromyalgia and osteoarthritis.

Customer Service Representatives are available Monday through Friday, from 8:30 a.m. until 7 p.m. ET.
