FROM THE NATIONAL LEGISLATIVE DIRECTOR —

n June 2nd the annual trustee reports on Social Security and Medicare Trust Funds were released showing an improved outlook indicating the Social Security Trust Fund is solvent until 2035, an improvement of one year than was projected last year. At that time, approximately 80% of benefits will be payable. The Medicare Part A Trust Fund for hospital care now has sufficient funds to fulfill its obligations until 2028, two years later than projected in 2021. Every Member of Congress knows that they must act to strengthen the solvency of these national programs. Social Security is funded through payroll taxes (6.2%), which currently apply to income wages up to \$147,000. Notably, thanks to a change by Congress, there is no wage limit on the Medicare tax of 1.45%. Polls continue to show that most Americans think our lawmakers should make a similar change to Social Security.

In order to shore up the system, lawmakers face a wide choice of different proposals. Applying Social Security payroll taxes to those above the wage base is a popular idea with the public, and known by its own campaign slogan, "Scrap the Cap". NARVRE has long supported a fair plan to have the Social Security tax on wages expanded as well as a plan to allow Medicare to negotiate directly with the Rx industry to lower the costs of prescription drugs in America. HR 5723, The Social Security 2100: A Sacred Trust Act, is a bill that includes both of those proposals, requiring wealthy Americans to pay payroll taxes on wages above \$400,000. This legislation would also increase our cost-of-living-adjustments (COLA) by adopting the Consumer Price Index for the Elderly (CPI-E) and based on the spending patterns of seniors. The Railroad Retirement Board (RRB) works closely with the Social Security Administration, and we need both

From the National Vice President —

ARVRE has come a long way since it was established in 1937. Throughout those years, we have seen many changes, such as adjustments to our retirement plan, changes in the structure of railroads and changes to our membership.

In recent years, our NARVRE membership has declined. This can be attributed to deaths, railroad operations moving to other locations, the reduction of railroad jobs or NARVRE is completely unknown to railroad retirees. The Railroad Retirement Board reports, as of September 2020, there were approximately 202,000 railroad jobs across the U.S. This was a decline of about 20,000 railroad jobs from the previous year. These railroad workers are not retiring but being laid off.

The Railroad Retirement Board also reports there are over 400,000 railroad retirees receiving full retirement benefits. However, just a small fraction of those railroad retirees belong to NARVRE. Ask yourself, why aren't there more. The simple answer is they are not aware of NARVRE and what we protect. Many times, we hear retirees say, "Well I never knew NARVRE existed". This is a concern to NARVRE whereas you and I must disseminate information about NARVRE and what we do for retirees.

Our National President and National Secretary-Treasurer have done a tremendous job in assisting Units in starting the many Unit Facebook pages. These Facebook pages allow us to have the NARVRE name to be-

any thanks to Former Vice President Tony Padilla, who due to family and personal issues, has stepped aside as National Vice President. He did an outstanding job presiding over the 42nd biennial Convention as President Tom Dwyer was unable to attend. We wish both the former National President and National Vice President nothing but the best.

A brief recap of the changes to the Bylaws and Policy Procedures Manual passed by the 2022 Convention Delegate are listed below:

• Resolution 1 allows the Governing Board by two thirds majority in case of emergency to devise methods of electing Officers without the necessity of conducting a National Convention.

• Resolution 2 Delegates concur in the designation of the Jones and Granger, Attorneys at Law to be NARVRE's official law firm. This arrangement is to be reviewed every two years by representatives of both parties.

• Resolution 3 costs to the NARVRE organization has continually increased over the years, the dues are to be amended single and couple Unit dues are now \$29.00 and \$39.00 while 801 Unit dues are now \$31.00 and \$38.00

• Resolution 4 did not make it out of the Finance Committee

• Resolution 5 Renewed the NARVRE Trademark and furthermore the future ten year renewal will no longer be required. At this point the Trademark was registered as incontestable and as indicated earlier, renewal will no longer be required.

Any new member to join NARVRE for the first time that pays their dues after July 1 will be paid up through the remaining current year and through the end of the next year. Again this is for NEW MEMBERS, one time only.

Visit our website www.narvre.us all the Membership Reporting Forms have been updated with the new dues rates, plus the Bylaws and Policy and Procedures Manual has been updated with the amendments approved by the Delegates of the 2022 Convention.

Additionally, thanks to Jerry and Cheryl Lambert in developing and designing the Presidential Plaque that was presented to Tom Dwyer at the Convention.

The tribute was conducted at the Convention in Mr. Dwyer's absence, but video was subsequently presented to him.

agencies to run efficiently with proper funding and adequate staffing.

There are many legislative proposals that committees must work through to finally get a substantive bill that can muster the needed votes to pass through both legislative chambers. Hopefully, we will have a standing bill that will be put up for a vote of Congress. H.R. 5723 has over 200 co-sponsors and would easily pass the House, even as written today. The Senate is a different story, but this is an election year and actions (or lack of) between now and November 8th can weigh heavy on candidates wanting our votes.

On the GOP side of the Senate, Sen. Rick Scott (R-FL), and chairman of the National Republican Senatorial Committee has released an 11-point "Rescue America Plan" that calls for the termination of every single federal law unless renewed by legislative action every five years. That would, of course, include Medicare and Social Security, and federal laws cover federal agencies, like the RRB. Scott's plan will also impose a tax increase on more than 100 million Americans, according to the non-profit Institute of Taxation & Economic Policy. History will point to a continual record of previous threats and attempts by the GOP to increase fees and/or implement cuts to retirement benefits. At this point in time, Congress needs to strengthen the national programs that we financed during our working years. We shall be watching the actions in the House and Senate. This is an election year, and we need to support those that support us. Election Day is on November 8, 2022, and 34 of the 100 seats in the Senate will be contested this year.

Big Arrests for Medicare Fraud

t doesn't pay to defraud Medicare, or so these people found out the hard way. In fact, it can cost money, jail time and loss of medical licenses for the people who give it a try. Here are some examples from the U.S. Department of Health and Human Services Office of the Inspector General (HHS OIG), as reported in June 2022.

Patrick C. Finney, M.D. from Paducah, KY, was accused of and admitted to knowingly filing false or fraudulent Medicare claims using false records and statements and conspiring to defraud Medicare into making false payments. Between November 2017 and August 2020, Dr. Finney submitted more than \$3 million in false claims related to durable medical products and genetic testing services. In regard to these fake services, he didn't have anything to do with the treatment of the Medicare patients, didn't speak to the patients, and he knew that the products and services he prescribed were not medically necessary.

Marc Sporn from Delray Beach, FL, was sentenced to 14 years in prison for crimes totaling \$20+ million related to health care and wire fraud. He also was convicted of evading his taxes.

Sporn owned and operated several tele-



marketing companies. These companies marketed medically unnecessary genetic tests to sell "prescriptions" for medically unnecessary genetic tests in laboratories. The outcome for Sporn was he received kickbacks and bribes. The "prescriptions" amounted to "doctors' orders", which were used to bill Medicare for medically unnecessary goods and services.

How you can help spot fraud and abuse You absolutely, hands down, are the best person to spot fraud and abuse in the Medicare program. You may ask, "Did you mean, ME?" and I do!

Here's how: When you receive your Medicare Summary Notices (MSN), please review each charge carefully. Be on the lookout for charges for services or items you didn't receive, charges for the same services billed twice, or charges for procedures or services that were not ordered by your doctor.

If you want help reading your MSN or you find something on it that appears to be wrong, you can call our toll-free Customer Service Line at 800–833–4455, Monday through Friday, from 8:30 a.m. to 7 p.m. ET. For the hearing impaired, call TTY/TDD at 877–566–3572.

We will discuss what is on the MSN with you. Sometimes the MSNs can be difficult to understand so we can review it with you. If there is a charge on there that isn't right, we can look into it for you.

Other resources for reporting suspected fraud and abuse include the Department of Health and Human Services Medicare Fraud Hotline. Their toll free number is 800–447–8477 or for TTY, call 800–377–4950.
