### FROM THE NATIONAL LEGISLATIVE DIRECTOR —

ach year, federal agencies are required to submit their fiscal year ✓ budget requests to the Office of Management & Budget (OMB), in preparation for the President's yearly budget. The Railroad Retirement Board (RRB) must submit a detailed filing of their projected budget for the next fiscal year, in order to properly administer for and on behalf of its' annuitants. The present day RRB funding is \$128M and the President's FY24 budget for the RRB is at \$138.575M, which would be an increase, except that it would only support about 729 full-time employees. Currently, the RRB is operating at 18 percent below its minimum staffing level, and 25 percent of those employees are retirement eligible. This percentage will climb to nearly onethird (32 percent) within the next two years. Therefore, the agency is requesting funding of \$173,744M for fiscal year 2024 to support 880 full-time employees, which is the same number requested in FY23. The FY24 number also includes a long-delayed and overdue \$10M to further IT modernization efforts. The projected number of 880 employees is an absolute as the agency continually needs to hire and train to manage proper succession planning. The increase in funding would allow the RRB to move into the modernized IT phase with sufficient employees to provide critical benefit service. The RRB have been under-funded and under-staffed for years, working with outdated IT systems. That leaves the RRB open to invasive cyber-attacks, unable to fully secure the personal information of annuitants and beneficiaries. The U.S. Congress needs to finally invest in new technologies for the RRB offices to provide services for rail workers and beneficiaries. It is therefore time to make contact with our Representatives in Congress on this issue. And keep in mind that many of

With the same fervor of renewal as mother nature, our leadership team is working at a relentless pace to rebuild and renew the NARVRE organization. Informational meetings were held in one the nation's largest rail

centers, Atlanta, GA, visits to Chattanooga, TN, and all units in Iowa. Under the direction and guidance of National Legislative Director, Gary Faley, NARVRE National President, Area 5 Director and former rail labor lobbyist, Tony Padilla is leading a contingency of NARVRE representatives who will be going to Washington DC to reestablish and renew our congressional contacts since the pandemic. us have newly elected Members that need to hear from their constituents drawing benefits from the RRB. The message is simple..."appropriate the necessary funding requests from the Railroad Retirement Board." The Medicare Board of Trustees recently released their report on the financial health of Medicare. The Board's projection indicates that the Medicare Part A hospital insurance (HI) trust fund, will be able to pay full benefits until 2031, gaining three years of solvency compared to last year's projection. However, if Congress does not take action, the Trust reserves will become depleted, at which time Medicare could pay 89 percent of benefits. NARVRE will continue to follow this and give credit where credit is due but will also report on any obvious actions that threaten the long-term solvency of the Medicare Trust Fund. Congress must begin to work together in a bipartisan fashion to resolve the looming financial crisis facing Medicare in the not-to-distant future. We will join with millions of seniors and support common sense proposals that strengthen the Medicare system, like the enactment of the Inflation Reduction Act which empowers Medicare to negotiate and reduce the cost of prescription drug prices in America. That legislation caps

insulin co-pays at \$35 per month and caps the out-of-pocket costs at \$2000 per year for seniors with Medicare Part D Rx plans. Fraud and abuse against Medicare must stop and the stealing must end, especially when those crimes are committed by companies involved in the administration of Medicare benefits. The Kaiser Health News (KHN) has been forthright in their reporting about alleged crimes committed by the largest Medicare Advantage (MA) insurers that manage Medicare benefits in lieu of traditional Medicare (TM). All fraud threatens the financial health of Medicare. There are warnings abound that speak to the very real possibility of a financial calamity that would call for the privatization of the national Medicare program. Congressional oversight also reports that the managed-care companies will take in a projected \$27 billion in excess payments as they spend roughly 6% more in providing benefits than TM. The Medicare Payment Advisory Commission (MedPac) continues to sound an alarm regarding the need for lawmakers to act on MA overpayments and oversight, in part, due to the strain those costs put on Medicare's finances. We will keep you updated on HR 1745, introduced by NARVRE supporter Rep. Lloyd Doggett (D-TX), soon after the KHN reporting on a shocking loophole. During that action, Rep. Doggett stated..."the ability of fraudsters to continue billing Medicare for services is outrageous. Wherever there are large amounts of government money, someone tries to steal it.".

#### Fraud and Abuse: Ophthalmology Kickbacks in Texas

edicare pays for medically reasonable and necessary cataract surgery. As always, all Medicare guidelines have to be met. However, some providers are not meeting the guidelines because they are paying other doctors for patient referrals.

Case in point: Arlington Ophthalmology Association, P.L.L.C. d/b/a Kleiman Evangelista Eye Centers ("K&E"), located in Arlington, Dallas, Plano, Southlake, Mount Pleasant, and Gun Barrel City, Texas, agreed to pay \$2.9 million in fines to settle "kickback" allegations related to paying other providers for patient referrals.

According to the government's investigation, K&E "routinely engaged in the practice of co-management of cataract surgery patients with optometrists who referred patients to K&E. Patients who undergo cataract surgery require post-operative monitoring and care. When post-operative care is rendered by another provider other than the surgeon, such as an optometrist outside the surgeon's practice, this practice is generally referred to as co-management." Also included in the press release: allegations say that K&E violated the Anti-Kickback Statute, which is when an entity pays money/trades & Defense goods/solicits or receives payment for Medicare, Medicaid, and other federally funded program services. This statute was created to ensure that a medical provider's judgement is not influenced by financial incentives.

The settlement found that K&E paid other optometrists for referring beneficiaries who received premium intraocular lenses (IOLs) or laser-assisted cataract surgery. The payment that the optometrists

received was in free continuing education

courses, dinners, and seats in the company's Texas Rangers stadium games.

The exact amount of the settlement was \$2,902,505. Included in the settlement was K&E's cooperation in providing information about the other providers who took part in this scheme.

If you believe your provider may be filing False Claims or is involved in a kickback scheme, please don't hesitate to call our Beneficiary Contact Center at 800–833–4455, or for the hearing impaired, call TTY/TDD at 877–566–3572. Customer Service Representatives are available Monday through Friday, from 8:30 a.m. until 7 p.m. ET.

We also encourage you to sign up for our free internet portal, MyRRMed. MyRRMed provides you with access to your Railroad Medicare Part B claims information, along with historical Part B Medicare

Summary Notices, and a listing of individuals you have authorized to have access to your protected health information (PHI). You can also submit requests to add or change your authorized representatives through the portal.
