The National Association of Retired and Veteran Railway Employees, Inc. is an association made up of active and retired railroad employees. NARVRE was organized in 1937, the same year that the Railroad Retirement Act became law. The purpose of NARVRE is to bring together these employees into an organization that is concerned about issues related to its members, with special regard to their rights under the Railroad Retirement Acts of 1937 and 1974. NARVRE is the only Federally Charted Organization whose sole purpose is the protection, promotion, and preservation of the Railroad Retirement System.
