FROM THE

NATIONAL PRESIDENT -

Prom time to time we get inquiries on the effects on coal and what real affect it has on the railroad industry in general. First there is the real world and than there is the political debate that goes on behind the scenes. You will see the debate in Congress on a bill authored by Rep. Ed Whitfield, R-KY and Senator Joe Manchin, D-WVA.

HR 3826. What this is all about is a fight between coal producing states and the Obama Administration over coal emissions by power plants. The railroads and rail labor have taken no position on HR 3826 because they have no "dog in the fight."

Is there concern over railroad retirement and the nation's railroad's hauling of coal. We are always concerned about any long-range effects on the railroad retirement system whether it is coal or anything

else. Railroads not only haul coal but Bakken oil, lumber, autos, grain products, perishables and trailer train products.

What this is all about is a debate over the Obama climate change policy and nothing more. Just recently the water was contaminated in the several counties in the Commonwealth of Virginia. The Environmental Protection Agency just announced that Alpha Natural Resources (Alpha) one of the nation's largest coal companies and 66 subsidiaries have agreed to spend \$200 million to install and operate wastewater treatment systems and to implement comprehensive system wide upgrades to reduce discharges of pollution from coal mines in Kentucky, Pennsylvania, Tennessee, Virginia and West Virginia. Overall, the settlement covers approximately 79 active mines and 25 processing plants in these five states. This settlement resulted from lawsuits against Alpha and its predecessor company Massey Energy. There was over \$27 Million is fines applied

as well.

The bottom line is this: railroads will continue to haul coal and its employees will continue to pay into railroad retirement. The fight is political and we are a third party.

From the National Legislative Director —

ail labor organizations have been working Capitol Hill urging members of Congress to support H.R. 3040, The Safe Freight Act. This legislation will require that freight trains and light engines used in connection with the movement of freight must have a twoman crew with one locomotive engineer and one conductor. HR 3040 was introduced after the July 2013 deadly crude-oil train derailment in Lac-Megantic, Quebec, on the Montreal, Maine & Atlantic Railway, Ltd, where 47 people died. That train accident had one crew member, working alone, and gave rise to this legislation, introduced by Representatives Michael Michaud and Chellie Pingree, both of Maine. A joint letter to Congress sent by BLET and Smart-TD noted that twoperson crews are the norm in both the U.S. and Canada, and that the many tasks that must be performed by the crew of a freight train cannot be accomplished alone. The letter further points out that current Federal Railroad Administration (FRA) regulations and railroad operating rules, dictate that a single person crew cannot make a Class 1



air brake test, one person cannot act as a first responder when a collision at a road crossing occurs, and one person cannot inspect their own train when it breaks in two or derails, including when there is the possible release of hazardous materials. Federal Railroad Administrator Joe Szabo has made it clear that the FRA believes that federal regulation needs to be implemented on two-man crews. FRA's website has stated that the Rail Safety Advisory Comm (RSAC) is expected to make recommendations on train crew size and hazardous materials. As information, the aforementioned joint letter notes that the Association of American Railroads (AAR) and the American Short Line and Regional RR Association

(ASLRRA) have sent memos to Congress opposing this legislation. In lieu of the obvious safety issues relative to a one-man train crew, as well as rail workers in our operating crafts paying into our retirement system, NARVRE is inclined to urge our membership to contact their members in Congress, and request that they support this important legislation, H.R. 3040. Also, please ask your Representatives to consider becoming a co-sponsor of "The Safe Freight Act", a bipartisan bill that will ensure that trains are operated safely everywhere in America. This bill will ensure that each train is operated by a crew of at least two people, to include a certified engineer and a certified conductor.

The White House has released it's FY2015 budget, which calls for increases in transit and rail programs by over 70 percent and establishes a new four-year \$10 Billion program to improve the nation's freight rail network. The full package calls for doubling the funding for investments programs (TIGER grants) and addresses an underfunded and broken infrastructure by bringing existing transportation systems to a state of good repair. It improves federal funding to replenish the Highway Trust Fund which is going broke. It addresses the obvious expiration date of October 1, when the current transportation policy (MAP-21) will expire, and envisions funding for a National High Performance Rail System to build on and improve a rail system for the future. NARVRE supports this overall vision that includes a 21st Century rail passenger service, but we've been here before, only to see it ignored or dismissed for to many years. The authorizing authority for Amtrak (PRIIA) has expired, and needs to be addressed, and this proposal from the President is a good place to start, but we realize that this is but a wish list full of proposals that will be hard to sell in today's Congress. We're overjoyed that Rep. Mica was forced out of the chairmanship on the House Transportation &Infrastructure Committee, and hopeful that Chrm. Shuster will lead with all transportation venues in mind, to include rail passenger service. We are also aware of other potential problems in the House Subcommittee on Railroads, as Chrm. Jeff Denham (R-CA) has stated that he prefers that Amtrak legislation should stand on it's own, rather than be tied to or merged with a larger surface transportation measure. We cannot believe that this statement has the future of Amtrak in mind, so we will remain focused on the hearings he has scheduled in his committee. All of these transportation issues, to include both freight and passenger rail, will be in front of Congress. When you contact your Representative in Congress on any issue, your address tells them you are a constituent. Remind them of your membership in NARVRE, as that tells them you are active and will be voting.
