have many members who have no choice and rely on information within the boundaries of NARVRE's Newsletter. One update is on Amtrak's former Sunset Limited passenger train route that previously ran through the southern states along the Gulf Coast. The endeavor to reinstate this train service from LA to FL has continually garnered more support from the traveling public but also from the local communities that look forward to an increase in commerce and new jobs from a new and modern Amtrak route. We should be reminded that early Senate legislation was directed by the unlikely partnership of Republican Sen. Roger Wicker (R-MS) and Democrat Sen. Cory Booker (D-NJ), who encouraged the support of fellow Senate members, but also, the business leaders along the Gulf Coast. It was their bipartisan persuasion that prompted the necessary funding for a study group that eventually provided the initial monies for the restoration of this train service. Now, all attention is on the Trump Administration and their commitment to a massive national infrastructure plan which must concur with existing legislation that includes

freight and rail passenger trains. And this Gulf Coast project will present itself as a central part of any new funding for passenger train routes. Latest reports show that more local Republican officials as well as GOP members of Congress have now signed onto this project which will serve to support new legislation this year. However, there is the worry that the needed momentum may be side-lined by the attention to other major issues like an overdue tax reform bill and finally agreeing on the GOP's obsession to repeal Obamacare. With regard to the financing of this important project, it will be important for this movement to latch onto the language of last year's bipartisan FAST ACT (Fixing America's Surface Transportation), which laid the groundwork for that bipartisan transportation package. This legislation already provides for a number of incremental rail investments which is the opening for other rail projects like the Gulf Coast run to advance through the Congress if not this year, then in FY2018. Importantly, the new President recently made comment on the obvious lack of higher speed rail in a meeting with airline executives. The quote from the President, according to "The Hill" follows ... "You go to China, you go to Japan, they have fast trains all over the place", "I don't want to compete with your business, but we don't have one fast train". CA constituents should remind Rep. Jeff Denham (R-CA-10th CD), Chair of the House SubComm on Railroads, that he should take these words seriously, rather than spend his time trying to derail the CalTrain Electrification project with delay tactics meant to stop all important rail progress in California. We will keep watch on this issue, as well as any Amtrak projects and the rail workers paying into railroad retirement.

In case you missed it, we have been following reports that the conservative and right-wing Heritage Foundation had mentioned railroad retirement in their 2017 fund-raising letter which outlines issues they're currently following as a powerful lobbying group in D.C. NARVRE took notice of this letter, and this office contacted Heritage asking for an explanation to such an alarming and offensive inclusion of our private retirement system. We did not receive a reply to any of our calls or emails, and we put the letter up on our website, as this was gaining ground throughout our association. Earlier this week, we received information from a creditable source that said Heritage denied writing anything on RR, as that is not an issue with them. Heritage also stated that their fund-raising letter did not even mention RR and that the information was not accurate. The final word was that while it is confusing, the source that spoke with Heritage said he takes them at their word, and doesn't believe they will be coming after our retirement program. He then promised to stay in touch with Heritage and their allies, and promised to alert us immediately if anything changed. While that is from a trusted person of character from within the railroad industry, we will remain vigilant in our mission to protect our railroad retirement system. In closing on the updates, the last report on the National Railroad Retirement Investment Trust (NRRIT) ending 9/30/16 was another good report from our investment managers. The Trust-managed assets and RRB assets held in reserve now totals \$26.5 billion. That is an increase of \$0.6 billion since the previous Quarterly Report ending June 30, 2016. More financial information is always available on the RRB website (www. rrb.gov). Outside of the downward hit everyone took back in 2008-09, NRRIT has done remarkably well for all of it's investors and annuitants. - Gary Faley,

The Governing Board in February 2017 voted to immediately suspend offering Lifetime Memberships for individuals and couples until the matter is resolved at the 2018 National Convention in Council Bluffs, IA.

The fact is, Lifetime Memberships are an unfunded liability and not economically sustainable. Current Lifetime Members are not affected by this decision.

Please remember unpaid membership dues are delinquent as of February 28. Narvre can no longer afford to mail the National Newsletter to members who are not current. Reminder post cards were mailed on February 22 to over 700 members; so, if you have not renewed for 2017 please do so soon as possible. As my colleagues have warned, we are facing challenging times ahead.

Attention all unit officers: the IRS form 990n returns will be completed by our corporate accountant for a discounted fee of \$8.00 for those who desire to take advantage of this service.

We have made significant progress with regard to updating our new database. New reports have become available and they are making it easier to statically track membership trends. For example: our New Member Report indicates 412 in 2016 and 97 so far in 2017.

From Palmetto, GBA In Response to the "Medicare at Age 76" Email: Part 2

ast month we discussed an inquiry from a member who had received an email entitled: "Medicare at Age 74: A MUST READ". In this email, several allegations were made regarding Medicare coverage. This article addresses the last issues listed in the email.

<u>Claim:</u> Cancer hospitals will ration care according to the patient's age.

<u>Answer:</u> FALSE. Medicare does not have an age limit when it comes to receiving medically necessary services.

<u>Claim:</u> The government mandates advance-care planning consultations. Those on Social Security will be required to attend an "end-of-life planning" seminar every five years.

Answer: FALSE. Medicare does not require 'end of life planning'.

You can speak to your health care provider about advanced planning directives, so that your wishes are known in the event you are not able to speak for yourself. This voluntary Advance Care Planning is a part of the Yearly "Wellness" visit and is a covered Medicare benefit, but you are not required to have this service.
