#### FROM THE NATIONAL PRESIDENT —

his year requirement to file your income taxes has been extended to May 17, 2021. It is also a reminder that Railroad Retirement is not taxable in all fifty (50 states). Railroad Retirement is taxable on the federal level only. Other income you may have such as investments can be taxable by the state.

The prohibition of states taxing railroad retirement is a federal law. Here in Minnesota back in 1988-89 NARVRE Unit 109 pursued a case in state tax court and was successful. Nothing has changed since on the federal level as far as the statute is concerned. Under Federal Statutory law states are prohibited under the following:


45 United States Code, Sec. 231 (m) provides in relevant part:

(a) Except as provided in subsection (b) of this section and the Internal Revenue Code of 1954 (26 U.S.C. Sec. 1 et. seq.) notwithstanding any other law of the United States or of any state, territory, or the District of Columbia, no annuity or supplemental annuity shall be assignable or be subject to any tax or to garnishment, attachment,

or other legal process under any circumstances whatsoever, nor shall the payment thereof be anticipated. (Emphasis added).

We have found accountants and tax preparers who are unaware of the statue and to those who may use Turbo Tax should be aware of that as well.

### FROM THE NATIONAL LEGISLATIVE DIRECTOR —

ver the years, after the Medicare Part D prescription drug benefit came to be, NARVRE has urged Congress to examine the problems inherent to the rising cost of prescription drugs in America. Various proposals have been introduced that attempt to change the law and allow the Health & Human Services (HHS) to negotiate the price of prescription medicines with the drug manufacturers on behalf of Medicare beneficiaries. The immediate problem lies in the Medicare Modernization Act of 2003 (MMA) which gave birth to the Part D benefit, which mandates that the government (HHS) would "not interfere with the negotiation between drug manufacturers and the pharmacies", and may not require a particular formula or create a price structure for the reimbursement of covered Part D Rx drugs. This clause has meant that the government (HHS) will have no direct involvement in negotiating or setting drug prices in Medicare Part D. Since 2006, Medicare beneficiaries have had access to prescription drug coverage through Part D, where private plans contract with Medicare. Problems are getting worse for Pt. D enrollees as out-of-pocket costs continue to rise and the weak financial incentives faced by Part D plans fail to control the high drug costs of medicines. Bipartisan bills addressing this issue have passed the House of Representatives but were stalled by the previous Senate leader, Mitch McConnell. Those bills need to be re-introduced this year in the new 117th Congress.

- The Elijah E. Cummings Lower Drug Costs Now Act passed the House on December 12, 2019, but died in the Senate. This legislation contains the following provisions and examples important to retirees:
- Medicare would be authorized to negotiate prices for commonly used drugs, saving

\$456 billion over 10 years, of which \$360 billion will be used to provide dental, hearing and vision coverage (CBO Estimates).

- Cap out-of-pocket costs for medicines at \$2000 a year.
- The Prescription Drug Pricing Act was introduced in 2019 in the Senate Comm. on Finance but was not considered in 2020, due to the interference of election year politics. This bill would limit yearly out-of-pocket costs to \$3,100, and also cap the amount of out-of-pocket costs that a beneficiary must pay in any single month. This particular bill will be key to the inevitable conference negotiations because of the bipartisan work of Sen. Wyden (D-OR) and Grassley (R-IA) in 2019-20.
- This bill would save seniors and Americans with disabilities \$72 billion in out-of-pocket costs in Medicare Part D and reduce premiums by \$1 billion. (CBO Est.)
- The Safe Affordable Drugs From Canada Act of 2021 (S.259) will require the FDA to permit Americans to import safe Rx drugs from licensed pharmacies. This bill will help lower costs of Rx drugs in America, and allow citizens to obtain proper prescriptions under FDA regulations (introduced 2/04/21).

These are many more proposals in Congress that address the drug manufacturing industry and the gouging of American consumers, and retirees that rely on Rx medicines while living on fixed incomes. The out-of-control rising costs of prescription medicines

and the substantial out-of-pocket fees is plainly seen as a grotesque abuse of Medicare beneficiaries. The drug industry has a captive audience and Congress has allowed the abuse to occur for far too long. The democrats hold the majority in both chambers and the White House and they must move on this issue. It is obvious that new medicines always need to be developed for the treatment of cancers, diabetes, and numerous chronic health problems, but the affordability problem is always heightened by soaring prices for these specialty drugs. Leaders of the drug industry have failed to attend Congressional hearings and have not explained why the cost of commonly used drugs are rising so dramatically and that includes generic drugs, which used to mean lower priced medicines. Congress must address the outright examples of larceny from U.S. taxpayers. In 2019, bipartisan

legislation labeled "The Right Rebate Act" was proposed to close a loophole that allowed pharmaceutical companies to misclassify their drugs and overcharge taxpayers by billions of dollars. As an example of misclassification, the HHS Inspector General stated that taxpayers may have overpaid for the EpiPen drug by as much as \$1.27 billion over 10 years. That bill would provide the HHS with additional authorities to monitor the drug manufacturers and require them to reclassify their drugs subject to new reporting and transparency requirements of the government. This legislation was included in a previous bill (IMPROVE Act) which cleared the House 400-11 in December of 2018, and was not taken up in the Senate. More as these bills move through the Congress.

# Covid Vaccine Fraud Concerns Rise as More People Become Eligible for Shots

As more people get the coronavirus vaccine, the level of COVID vaccine fraud could rise, particularly around vaccine passport and scheduling apps and vaccination cards.

Right now, there are no programs in the U.S. that use or require a vaccine passport app. If anyone receives a message about one, it is a scam trying to steal people's credentials or get them to pay for a fake app or service.

There are apps to schedule a vaccine. However, an app that asks for money or personal health information (PHI) should raise a red flag.

Many people are posting pictures online of their vaccination cards once they've gotten the COVID shot. The Identity Theft Resource Center (ITRC) does not recommend people post these photos unless they blur out their personal information to reduce identity risks.

According to the Centers for Disease Control and Prevention (CDC), well over 100 million vaccines have been administered, and more than 12 percent of Americans are fully vaccinated. States across the U.S. are moving beyond limited groups to vaccinate the general public, leading to concerns over COVID vaccine fraud. There are several different ways identity criminals could attack.

### The Open Payments Program Revisited

ore than 7 years ago, we announced the Open Payments initiative. The goal of this program then and now is to increase public awareness and knowledge of the financial relationships between drug and medical device companies and physicians and teaching hospitals.

Open Payments is described by the Centers for Medicare & Medicaid Services (CMS) as "a national disclosure program that promotes a more transparent and accountable health care system. Open Payments houses a publicly accessible database of payments that reporting entities, including drug and medical device companies, make to covered recipients like physicians." It further says: "Please note that CMS does not comment on what relationships may be beneficial or potential conflicts of interest. CMS publishes the data attested to by reporting entities. The data is open to individual interpretation."

In summary, this is a program that provides data on how much your doctor or teaching hospital receives from drug companies or medical device companies. The data does not state what kind of relationship

exists between these entities. It is not a finding of fraud or abuse. It is only an accounting of dollars that were spent.

To test the program, I went to the site and entered my general practitioner's name. I found that she received \$1,762.10 with 116 payments in 2019. The payments were primarily for food and beverages (96.3%). AstraZeneca Pharmaceuticals LP was the highest contributor, followed by Novo Nordisk, Inc. There were a total of 10 companies that bought her food or beverages that year. The data shows that she is well below the norm for the doctors in the United States (the mean general payment for 2019 was \$3,736.21. Knowing this, I am not concerned about my doctor).

The Open Payments data is available for the years of 2013 – 2019. CMS will publish the data for the year 2020 on or by June 30, 2021.

This video was created by CMS and is part of their national educational program.

This will let you receive emails from us about topics you are interested in getting updates about. We won't share your email address with anyone.

We also encourage you to use our free, beneficiary website portal called 'MyR-RMed'. MyRRMed provides you with access to your claims information, along with historical Medicare Summary Notices, and a listing of individuals you have authorized to have access to your protected health information (PHI). You can also submit requests to add or change your authorized representatives through the portal. To access MyRRMed, please visit us at www.PalmettoGBA.com/MyRRMed.
