- 2. Contain the signature of the author.

3. Include the date adopted and the Unit number or the local Unit.

FROM THE NATIONAL LEGISLATIVE DIRECTOR —

e are awaiting the outcome and decisions from the conference committee assigned to work through the differences in the House & Senate bills on the GOP tax reform legislation (12/15/17). Both versions of these tax measures are primarily partisan with no indications of any compromised outcomes in their final products. The crux of these tax law proposals are a mixture of GOP ideology and a throwback to the tried and failed practices of trickle-down economics. It has been 3 decades since the last tax reform legislation was passed, but that process in 1986 was deliberative, with testimony from experts in 30 different public hearings (today=zero hearings) and amendments that were actually proposed by both parties and made part of a package that was passed in the Senate by a bipartisan vote of 90-10. But those days of working together in regular order are long gone, for many reasons, all political and/or driven by the almighty dollar, and both parties share this reality today. However, the one similarity in past tax reform proposals and present-day legislation is the GOP party-line platform

4. Resolutions are to be submitted to the National Headquarters at least seventy-five days prior to the date. of the convention.

5. Resolutions may be reworded, combined and/or rewritten in an easily understood form before being presented to the delegates.

These instructions need to be carried out so all Resolutions can be mailed out to all Units for local action prior to the convention. Please adhere to these guidelines in your deliberations.

This convention will be historic as we need to make some major decisions that will affect our existence in the near future. We see healthy Units wanting to close due to lack of members stepping up to become officers, we see others closing because there is no growth in the area because the railroad presence has been diminished.

economic growth which generates revenue, while reducing spending. That will mean instituting structural changes to Social Security and Medicare for the future."- Sen. Marco Rubio, 11/29/17. What "structural changes" actually means, is that their 2017 proposals will turn Medicare into a voucher program ran by the private, for-profit healthcare industry. This office has written and talked about this GOP agenda for years, but presently, they are talking openly about this

scheme, because they now have the power to enact it, with no regard to the financial and/or medical harm it will bring to seniors and the disabled. In that regard, the House bill proposes to repeal the current medical expense deduction which millions of seniors rely on to mitigate the high out-ofpocket fees for medical and long-term care costs. The GOP leadership has portrayed this as closing an expensive loophole, but this deduction affects specific people who spend 10 percent of their income on medical bills, typical for those facing serious illnesses like cancer or who have children with

severe birth defects. The repeal of this deduction is a brazen act that should be reconsidered and reversed in the conference committee meetings. This Congress and committee should look elsewhere for savings to pay for their handouts to the ultra-rich that do not need nor asked for this windfall. This office has written to many Congressional leaders, hoping they would address more obvious ways to reduce the cost of Medicare. Many non-profit agencies (such as Taxpayers for Common Sense) have written on eliminating waste and improper payments such as investigating duplicate services and billings. TCS has reported that companies are billing for unproven testing services and using millions of dollars in Medicare payments as funding for their new start-up companies. The bottom line is that the government made improper payments totaling \$144.3 billion in 2016 alone, and \$96 billion of that was related to Medicare and Medicaid. This equals \$960 billion over 10 years, or twice the Budget Resolution amount of the \$473 billion they now plan to cut from Medicare. Our Representatives in Congress need to focus on eliminating waste and improper payments, to build and strengthen the Medicare system, rather than cut funds from Medicare to implement a new system of vouchers for the profits of the healthcare industry.

So, presently, we await the outcome and decision of the Conference Committee, and the vote of both parties on a negotiated final bill (H.R. 1). Also, the possible shut-down of the government was averted by a bipartisan vote to extend the spending and funding of all gov't agencies (to include the RRB and Social Security) to yet another deadline of December 22nd.

UPDATE (Dec. 22, 2018): Before heading to Florida for the Christmas holiday, President Trump signed the GOP tax bill in the Oval Office.

Happy Holidays and a healthy and prosperous New Year. Seniors and retirees truly need to re-evaluate priorities in 2018, and vote to elect people that will protect issues important to them and their families. And more seniors need to exercise...get out and vote! Thank you all.

Palmetto GBA is pleased to offer MyRRMed, located at ww.PalmettoGBA.com/MyRRMed. It is our free Internet-based, beneficiary 'portal' that lets you access your healthcare data. (A 'portal' in this sense, is a website that functions as an entry point to accessing your data on the Internet).

Portal Functions:

At this time, you can use the portal to access:

•Status and details of your last 22 Railroad Medicare claims on file

•Historical Medicare Summary Notices (MSNs)

You also can view a list of individuals with whom you have authorized Railroad Medicare to grant access to your healthcare information.

Creating an Account:

Accessing MyRRMed information is easy. Just follow the link above and enter the following information:

Once you have entered this information and it is verified within our files, you will create a user name and password.

Logging into the Portal:

To enhance the security of Medicare data, the Centers for Medicare & Medicaid services (CMS) requires Palmetto GBA to adhere to several security requirements. Some of these security features require the user to verify their identity using their email address.

This is done through what's called 'Multi-Factor Authentication', or 'MFA'. MFA has the user log partially in, and then the system sends a 'passcode' (a unique and random set of numbers) to either your telephone by text or your email for you to enter on the portal access page. Upon each log in, users are required to enter an MFA code in addition to their password to access MyRRMed. CMS requires that Medicare contractors use MFA as a secondary level of security to protect beneficiary data.

When is the Portal Available?

MyRRMed is generally available 24 hours a day, seven days a week. However, certain functions are only available from 8 am to 7 pm Eastern Time (ET). These include accessing claims data and MSNs.
